PRODUCT DESCRIPTION

- Duravit toilets are available in wall faced close coupled, floor mounted for inwall cistern, or wall hung for inwall cistern format. Duravit bidets are available in either wall hung or floor mounted models. All Duravit pans, cisterns, bidets and urinals are manufactured from vitreous china.
- All Duravit toilets & bidets are suitable for domestic use or commercial use.
- Duravit toilets & bidets are available in gloss white with selected toilet models available in matt white, or coloured finish. Selected toilet models can have hygiene glaze applied at additional cost.
- The Duravit D Code Accessible Wall Hung Pan can be installed to meet the requirements of people with disabilities (as per NZS4121.1)
- All Duravit toilets & urinals have been tested and comply to WELS (Water efficiency labelling scheme) AS/NZS6400 4.5L/3L flush.

SCOPE OF USE

- Duravit toilets, urinals and bidets are intended for use in domestic or commercial bathrooms.
- They are suitable for use in all water pressure settings, with maximum operating pressure of 500kPa.
- Duravit toilet suites can be installed with back entry water supply.
- Duravit toilet suites & bidets are available in floor mounted or wall hung models (depending on range).
- Duravit D Code Accessible Toilet Suite can be installed to comply to requirements for people with disabilities. NZS4121.1

CONDITIONS OF USE

- Duravit toilets, bidets and urinals must be installed by a registered plumber in accordance with the installation instructions provided with the product and to AS/NZS3500 plumbing regulations.
- These products are intended for domestic and commercial applications.
- Cleaning shall be done in accordance with the manufacturers cleaning instructions.
- Solvent cleaners should not be used on toilet seats or other plastic parts.
- The cleaning products required to clean VC surfaces is determined by the water quality (ie hardness/Lime content).
- Pan weight restrictions of 400kg (as per Watermark testing AS1172.1)
- As per AS/NZS3500 Plumbing Regulations "Inline filters and PLV (pressure limiting valves) (500kpa) should be installed at each premises to protect the life of valves and washers.
