- Duravit inwall cisterns are made from polypropylene and can be recycled.
- All cisterns are suitable for domestic or commercial use.
- Duravit In-Wall cisterns are concealed within the wall cavity and have face plates in different colours and designs.
- All Duravit cisterns comply to NZ's WELS (Water efficiency labelling scheme) with either an AS/NZS6400 4.5L/3L flush.

SCOPE OF USE

- Duravit In-Wall cisterns are intended for use in domestic or commercial bathrooms.
- Suitable for use in all water pressure settings, with maximum operating pressure of 500kPa. (As per AS/NZ3500).
- Duravit In-Wall cistern & face plate can be matched to SensoWash Starck f shower seat & matching Duravit toilet pan.

CONDITIONS OF USE

- Duravit Cisterns must be installed by a registered plumber in accordance with the installation instructions provided with the product and to AS/NZS3500.2:2021 plumbing regulations.
- These products are intended for domestic and commercial applications.
- These products are imperious to moisture.
- As per AS/NZS3500.2:2021 Plumbing Regulations - "inline filters and PVL (pressure limiting valves 500kpa) should be installed at each location to protect the life of valves and washers.
