PRODUCT DESCRIPTION

- Duravit vanities, wall storage and mirror cabinets are constructed using an E1 moisture resistant board and include a painted or wooden laminate surface.
- · Vanity models are designed with drawers (design is model dependent) and are designed to be wall hung.
- Wall Storage units are wall hung.

SCOPE OF USE

- Duravit Vanities, Storage units and Mirror Cabinets are designed for domestic or light commercial applications.
- Designed for use with single tap mixers mounted in the vanity top or wall mounted (based on specification at time of ordering)
- Models are Wall Hung.
- Compatible with plumbing systems installed to AS/NZS3500.2:2021 plumbing regulations.

CONDITIONS OF USE

- This product is intended for domestic or light commercial use only. It is not recommended for high use applications such as public amenities, schools, sports facilities, factories, or commercial premises etc.
- This product is not suitable for accessibility facilities.
- Product must be installed by a Registered Plumber and waste and water be connected in accordance with the manufacturer's installation instructions and to AS/NZS3500.2:2021.
- Maintenance and cleaning must be carried out in accordance with the installation instructions.

- F2/AS1, First Edition Amendment 3, 2017. G1/AS1 Duravit Vanities are required to be connected to a waste system to assist the removal of the water as per AS/NZS3500.2:2021 Plumbing Standards and should be installed in accordance to the manufacturers Installation instructions and by a registered plumber.
- G12/AS1 Water supply to vanities via tapware should be provided in accordance to AS/NZS3500.2:2021 in relation to
 making sure the supply does not cause backflow or contamination into the potable water system. All work should be
 carried out by a registered plumber.
