PRODUCT DESCRIPTION

- Kaldewei vessels and wall hung basins are made from steel enamel (a combination of robust steel with resilient glass to create an inseparable bond).
- Intended use is a vessel placed on a vanity top or furniture, or wall hung, for hygiene and personal cleaning purposes.
- Sizes vary depending on model.
- Colours vary by range, with a wide selection available on request.
- Designed to be used with top mounted mixer tapware, or wall mounted mixers – depending on model.

SCOPE OF USE

- Kaldewei basins and vessels are designed for domestic or commercial applications.
- Check Spec Sheet to determine which models are suitable for wall mounting or bench top mounting on a vanity.
- Designed to have water supplied via a bench-top mounted basin mixer or wall mounted basin mixer.
- Product is robust, is highly resistant to mechanical stress, burning or smoldering objects do not leave marks on the surface, is UV resistant, and common household detergents, cosmetics or bath additives will not harm the Kaldewei steel enamel.
- All plumbing must be installed by a registered plumber and in accordance with AS/NZS3500.2:2021 Plumbing Regulations.

CONDITIONS OF USE

- Kaldewei basins and vessels must be installed by a registered plumber in accordance with the installation instructions provided with the product to AS/NZS3500.2:2021 plumbing regulations.
- Cleaning and maintenance shall be done in accordance with the manufacturer's warranty/cleaning instructions.
